## **Public Questions – Not on the Agenda**

My Young asked why the minutes of the last meeting made no reference to the skate park being repaired. Cllr Croucher stated that some welding was required to fix problems identified in a recent inspection report. He had identified a welder and will try and progress the work. Cllr Enticknap-Green stated that he was able to help with welding if needed.

Mr Cameron read a statement about local developments. He also asked about the delay in starting the neighbourhood plan. Cllr Garnett stated that there had been a delay due to the time taken for EHDC to agree her Disclosure of Interest Form. However, she had visited a number of other councils that were at a more advanced stage in preparing their plans. It was hoped that once started the plan could proceed quickly. In answer to a further question, it was stated that the first meeting could be held some after the summer break, possibly September 2016.

Mrs Hall asked when the public toilets will be reopened. The Executive Officer stated they should be open the following week.

A question was raised about the proposed new road. Cllr Glass stated that the road could not be used as a reason to hold up the development. The document was only an outline proposal. Further detail will be available at a future meeting for consideration and will be subject to consultation.

Mr D Ellis stated that he had volunteered to be a member of the neighbourhood plan group but had heard nothing about his application. Cllr Garnet stated that there was no specific number of volunteers in mind and volunteers were still being sought. It was agreed that volunteers will be contacted by the council to update them.

Mr B Ellis asked why the council never fly a flag on the flagpole at the millennium centre. It was suggested that a flag be flown for the queen's birthday.
