The timber cladding used is inappropriate and unsympathetic to the style of the original building, particularly given the Lodge's prominent location along a bridleway at the entrance to Foley Manor Estate.

Members unanimously agreed to object to the application on the above grounds. It was proposed that an additional objection be made on the grounds that the size of the extension is out of keeping with the building it is attached to. Cllrs Garnett and Jerrard were in favour of this additional objection and five members were opposed to it.
